FOSTER AGREEMENT

I, _____, hereby acknowledge and agree that the following terms and conditions apply to my fostering of said equine(s) from **Paradise Farm Rescue and Sanctuary**. I further acknowledge and agree that failure to comply with any of these terms and conditions will be considered a breach of the Foster Agreement, in which case, **Paradise Farm Rescue and Sanctuary** will be entitled to pursue the remedies set forth below.

This Foster Agreement is entered into this _____ day of _____ 2022 between **Paradise Farm Rescue and Sanctuary** and _____

(herein after referred to as "Foster") and is binding for the lifetime of the equine(s), as herein defined.

The Foster agrees, in accordance with this Agreement, to foster and care for the equine(s) known as:

Paradise Farm Rescue and Sanctuary agrees to temporarily transfer care of the equine(s) to the Foster subject to the conditions set forth in this contract/agreement. _____

READ THIS PARAGRAPH IN QUOTES BELOW AND ACKNOWLEDGE WITH YOUR SIGNATURE:

"The Foster shall **not sell, give away, lend, lease, send to auction, or sell for slaughter** the equine(s). If the Foster arrives at a point that can no longer keep the equine(s), the Foster agrees to donate the equine(s) back to **Paradise Farm Rescue and Sanctuary** or give **Paradise Farm Rescue and Sanctuary** first right of refusal. If the equine(s) is/are found to have been sold, given away, disposed of, or transferred in breach of this

contract/agreement, **Paradise Farm Rescue and Sanctuary** shall have the right to prosecute to the fullest extent of the law for fraud, conversion, breach of contract, and any other legal remedies, including, but not limited to, injunctive relief.” _____ (signature)

If **Paradise Farm Rescue and Sanctuary**, in their sole discretion, finds the Foster to be in breach of the terms and conditions of this Agreement, for any reason, including but not limited to, neglect, mental or physical abuse of the equine(s), the Foster agrees and acknowledges that an authorized representative of **Paradise Farm Rescue and Sanctuary** may enter onto the property described in this Foster Agreement or any property where the equine(s) is/are located and take immediate possession of the equine(s). _____ (initials)

I further agree and acknowledge that a breach of the terms and conditions of this Agreement shall result in a complete waiver and termination of any and all rights of use, ownership, or possession that the Foster may have of the equine(s). Further, the Foster agrees to sign a Bill of Sale transferring the equine(s) back to **Paradise Farm Rescue and Sanctuary**, as well as any paperwork associated with the transfer of breed registration papers. _____ (initials)

The Foster’s failure to provide proper care and maintenance for the equine(s) consistent with generally recognized standards for equine health and maintenance and all other provisions of this Contract/Agreement, or if the equine(s) is/are found to be abused or neglected, **Paradise Farm Rescue and Sanctuary** will prosecute to the fullest extent of the law following her recovery of the equine(s). This also applies to the original condition of the equine(s) who may have been directly adopted from a kill buyer or kill pen, feedlot situation – in other words, if the said equine(s) is/are in worse condition than when in the kill pen or in possession of kill buyer. _____ (initials)
